TUESDAY 24TH FEBRUARY

MINUTES

PRESENT: Clirs Colin Price (Chairman), John Dawson (Vice Chairman), Paul Bratt, Diane Elphinstone, Gerald Kay and Ann Sheridan

PUBLIC PARTICIPATION

The following matters were raised: a gas pipeline marker near Station Road crossroads has been damaged. The Clerk will report this to the relevant organisation. A job description for the caretaker was requested. All requests for the caretaker must be made through the Clerk. It was confirmed that leaves cleared from pathways could be taken to Bleak Bank Farm for disposal. Other locations for disposal within the village were discussed. The missing gate at the north end of Clapham underpass reportedly belongs to NYCC Highways.

1. Apologies for Absence: None

2. Code of Conduct and Disclosable Pecuniary Interests

- a. Councillors did not record any Disclosable Pecuniary Interests (DPI) in relation to items on this Agenda.
- b. No requests were made for DPI dispensations in connection with items on this Agenda.

3. The Police Report

The Chairman, Clirs Dawson, Elphinstone, Sheridan and other local parish council representatives attended a meeting with the Police and Crime Commissioner (PCC) for North Yorkshire to discuss policing in the local area. Various topics were discussed including the Country Watch initiative, progress of local investigations, effectiveness of middle management in the police service, and the impact that reduced Government funding will have on police officer numbers.

4. Highways and Street Lighting, Road Signage and Boundary Markers

a. Requests for action on highways, streetlights, road signage and boundary markers Potholes at Bleak Bank Farm and Crooklands will be reported.

b. Updates and further action on outstanding issues

NYCC Highways has ordered repairs for the pot hole near Keasden Crossroads, the section of road outside the Temperance Hall and blocked drain at Clapham Station. The weight limit sign near Keasden Crossroads will be replaced and the flooded section of road near Calterber Bridge will be excavated. Local Estate Agents will again be asked to remove their signage from road verges.

The Clerk will liaise with NYCC Highways re ownership of the gate at Clapham underpass, CDC regarding the re-installation of the Station Road Street Sign and Network Rail to further discuss painting the footbridge at Clapham Station and railway bridge over Station Road.

Works to strengthen viaduct should be finished in May 2015.

5. Minutes of the previous meeting

Council **RESOLVED** that Minutes of the Clapham cum Newby Parish Council meetings held on 27th January 2015 should be approved and signed by Cllr Price, Chairman, as a true and accurate record. There were no matters arising not already covered in the Agenda.

6. Ongoing Issues

6.1 Installation of the new fingerpost sign at Clapham Station

The new sign should be installed this week.

6.2 Development of the Old Mercedes Garage site – there were no updates

6.3 Parish Maintenance Matters

a. The Clerk has contacted YDNPA again to request that the Woodland Officers inspect the holly bush on the east embankment of St James Churchyard.

Grass cutting in St James churchyard was discussed. Although permission has been given to use the mower

belonging to the Parochial Church Council, a local resident has expressed an interest in cutting the grass using his own equipment.

It was RESOLVED that at least 2 quotes should be obtained from interested parties for the 2015 grass cutting contract.

b. Appointment of a new lengthsman, the job description/task list and budget

After due consideration, Council RESOLVED that the position of lengthsman will be offered to Peter Everson. Cllr Dawson will liaise with Mr Everson regarding the task list, obtain copies of the relevant insurances and confirm the rate of pay. It was noted that the amenities budget for 2015-16 is £2056.

c. Allocation of the Forest of Bowland AONB grant

A guote for guttering works near Keasden Church has been received from Robert Close.

It was RESOLVED that 2 more quotes should be obtained for the works. The Chairman will contact prospective contractors.

Thanks to Cllr Ireton, CDC has provided free advice and stated that no advertising consent is required to install a parish notice board at Clapham Station. The Clerk will contact the landowner to request their permission to locate the notice board on their land.

A member of the public left the meeting.

6.4 Provision of Hyperfast Broadband

Cllr Sheridan reported that B4RN has approved the fibre network routes and thanked Simon Peach and Ian Jones for the hard work they have put into this. Dates for digging trenches will soon be arranged. A meeting will take place on 14th March to increase awareness of the project in Newby.

6.5 Development of the village shop as a community enterprise

Council noted that Clapham Community Shop Ltd has recruited a full time shop manager, is busy training volunteers and carrying out refurbishments works in preparation for opening in March. An interview with the post office will take place on 5th March.

7. Meeting with the Police and Crime Commissioner for North Yorkshire

8. The Ornamental Drinking Fountain

The Executors of Ingleborough Estate are supportive in principle to re-instating a water supply to the ornamental drinking fountain either via mains water or Clapham Beck. Members discussed the cost effectiveness of each option.

Council RESOLVED to investigate the cost of sourcing water from Clapham Beck via a solar pump. The Clerk will contact 3 local contractors to obtain estimates.

9. Webpage development

It is hoped that Clapham Development Association will formally give permission for the parish council to develop a page on its website, www.claphamyorkshire.org.uk, at their meeting in March. In the meantime, the Clerk will liaise with the website administrator to make preparations.

10. Temporary road closure for the Clapham Street Fair

Council RESOLVED to support an application from the Parochial Church Council for a temporary road closure on Saturday 25th July 2015 for Clapham Street Fair.

11. Development of a Community Emergency Plan (CEP)

Cllr Elphinstone will be attending a community resilience event run by RAY to aid the development of a CEP. The details of the plan were discussed including the creation of an emergency box, the need for a meeting point and development of a communication tree.

RESOLVED that an article should be written for the Clapham News asking for volunteers to be a point of contact (part of the communication tree).
