#### Highways, Streetlight, Road Signage and Boundary Markers

#### 6.1 To receive requests and decide further action on:

i) Footpath between Station Road and Growing with Grace

The Council **RESOLVED** that this was not a matter for them since this is Highways Land

ii) Church Avenue Sign by bridge

The Council **NOTED** that the missing sign had been reported by the Clerk and was now with "Craven" to reinstate.

#### Byways Open to All Traffic Update

The Council NOTED the "interim" report received from the Inspector with the decision that Thwaite Lane should remain a Bridlepath rather than become a Byway Open to All Traffic. The only reason that this is an interim report is that the "tunnel" section currently has no designation and it is recommended that this becomes a Bridlepath too and this now has to go through a consultation period.

#### To receive information on the following ongoing issues and decide further action where necessary:

#### 8.1 Parish Maintenance Matters

- i) To consider whether any work should be assigned to independent contractors
  - a) Potential Closed Churchyard Repairs.

Following the quinquennial review various potential repairs have been noted, none being "urgent" and a number already having been completed by the PCC. The Council RESOLVED to note the items but to take no action at the present time.

### 8.2 The community emergency plan, community defibrillator training and other topics related to the emergency services.

i) New Defibrillator at Green Close

The Council NOTED that the North Pennine Potholing Club had now installed a defibrillator at their facility at Green Close, now bringing the total within the parish to 5.

#### 8.3 Neighbourhood Planning

The Council NOTED that the Inspector has now passed the Plan as clear to proceed to referendum after some minor amendments. The main issue being the quality of some of the plans used and so alternatives will now need to be sourced.

#### 8.4 Climate Emergency

i) Dales House Bird Programme

YDMT has asked the Council to write a letter of support for a grant application to the National Lottery Fund in respect of nesting boxes for a number of bird species. The Council RESOLVED that they were happy with the draft proposed and the Clerk should sign the letter on behalf of the Chairman.

ii) Northern Powergrid Grants

The Council had been advised of a new round of grants for energy resilience projects being available. The Council NOTED these but felt there were no potential projects which may be eligible.

#### 12. Matters for Consideration

#### 12.1 To receive and respond to items of correspondence received prior to this meeting

- i) Mobile Telephone coverage in the village Discussion was had as to whether 999 calls can still be made when no regular service is available (handsets often showing emergency calls only). This has subsequently been proved to be the case.
- ii) Clapham Village Christmas Decorations
  - The Council had been approached by the Community Shop for potential funding of some decorations for the village for the "Christmas evening" to be held by local business on 28th November. Whilst the idea was supported in principle the Council had guestions as to whether the businesses themselves were to contribute, who would the Council pay and who would organise. It was RESOLVED that Cllr Farrer would investigate there matters and revert at the next meeting

#### iii) Citizen's Advice request for donation

The Council had once again been approached by North Yorkshire Citizens Advice for a donation. It was **RESOLVED** that the Council would make a £100 donation as provided for in the budget and the Clerk to bring back the formal payment request to the next meeting.

## 12.2 To receive and respond to items of correspondence received too late for inclusion on this agenda

i) Yorkshire Dales Local Plan Consultation

The Council **NOTED** the plan has no designated housebuilding in Clapham

ii) Planning Application ZA24/26291/FUL – The Old Dairy, Hollin Lane, Mewith - Demolition of existing storage barn and construction of new extension to existing bungalow.

Concerns were raised regarding the scale of the proposed extension and the fact that previous planning stipulations had not been adhered to. It was **RESOLVED** that Cllr Sheridan would undertake further investigations and advise the Council whether an additional meeting was required in order to agree a response

iii) Planning Application ZA24/26274/HH – Westavon, Cross Haw Lane – Erection of single storey rear extension

The Council **RESOLVED** that they supported this application

iv) Forest of Bowland Landmark Trees funding

The Council **RESOLVED** that this was something to pursue and suggested either Keasden Crossroads or ST Matthew's churchyard as being potential locations. The Clerk is to contact the Ingleborough Estate and St Matthew's PCC for their views as the Landowners of the sites in question. The matter to be discussed further at the next meeting
