T9-Maple-remove 3 lowest limbs to allow more light into the caravan and decking area For the following reasons:

The work isn't deemed to be appropriate or necessary as there is ample clearance underneath. Crown lifting creates wounds on the stem that would be vulnerable to disease and decay and also affects the trees mass damping and the trees ability to photosynthesize. And **Grants Permission** for the following which is subject to the following Condition(s) and Reason(s) which are laid out in the order by which they must be complied with:-

T1 Oak-Fell

T2 Oak-Fell

T3 Oak-Reduction by 3 metres

T10-Bird Cherry-Fell

T11-14-Bird Cherry to thin out group and allow development of remaining trees Subject to the following conditions:

1) Replacement Trees: The 2 felled Oak are to be replaced by 2 no. Lime (Tilia sp.) within 2 metres of the felled tree stump. The trees are to be of at least 175cm height (half standard) and are to be planted within the first planting season following the felling (Nov-Mar). Trees are to be planted in a prepared pit, which is 50% larger than root ball of the tree to be planted. The sides of the planting to are to be forked over to help alleviate compaction and allow the tree roots to become established. Tree to be planted with the root collar at the same level as the surrounding soil levels and appropriate rabbit guard used. Trees to be anchored with a single stake and attached the trunk of the tree at approx.1 metre above ground level. Stakes to be driven into the ground clear of the root ball. If within a period of ten years from the date of the planting of any tree that tree, or any tree planted in replacement for it, is removed, uprooted or destroyed or dies, or becomes, in the opinion of the local planning authority, seriously damaged or defective, another tree of the same species and size as that originally planted shall be planted at the same place, unless the local planning authority gives its written consent to any variation.

Reason: In the interest of visual amenity and perpetual tree cover.

2) All work to BS 3998 (2010) for safety and for future health and viability of the trees.

Reason: In the Interest of the safety of persons and properties, including any neighbouring trees which are not to be felled, and in the interests of the health of the trees upon which the work is to be carried out.

3) Time Limit for Commencement of Tree Work: No tree operations specified in this consent shall be carried out later than 2 years from the date of this notice. If for any reason such works are not carried out within this period, a new and separate application must be made to the Local Planning Authority.
